**A BYLAW TO REPEAL THE INTERMUNICIPAL COLLABORATION FRAMEWORKS WITH THE SUMMER VILLAGES OF ITASKA BEACH, SUNDANCE BEACH AND GOLDEN DAYS**

**WHEREAS**

Pursuant to 708.28(1) of the *Municipal Government Act*, municipalities that have common boundaries must create a framework unless they are members of the same growth management board; and

Pursuant to 708.32(1) of the *Municipal Government Act*, the municipalities that are parties to a framework must review the framework at least every 5 years after the framework is created, or within a shorter period of time as provided for in the framework; and

Pursuant to 708.33(1) of the *Municipal Government Act*, municipalities that are parties to the framework must each adopt a bylaw or resolution that contains the framework; and

The Councils the Summer Villages of Itaska Beach, Sundance Beach and Golden Days along with Leduc County wish to streamline processes by approving the frameworks by resolution and therefore the Council of Leduc County wishes to repeal the Intermunicipal Collaboration Frameworks with the Summer Villages of Itaska Beach (Bylaw 21-19), Sundance Beach (Bylaw 22-19) and Golden Days (Bylaw 23-19).

**NOW THEREFORE**

be it resolved that the Council of Leduc County, duly assembled, enacts as follows:

1. That the Leduc County and the Summer Village of Itaska Beach Intermunicipal Collaboration Framework Bylaw No. 21-19, attached as 'Schedule A', is repealed upon this bylaw coming into force.
2. That the Leduc County and the Summer Village of Sundance Beach Intermunicipal Collaboration Framework Bylaw No. 22-19, attached as 'Schedule B', is repealed upon this bylaw coming into force.
3. That the Leduc County and the Summer Village of Golden Days Intermunicipal Collaboration Framework Bylaw No. 23-19, attached as 'Schedule C', is repealed upon this bylaw coming into force.
4. This bylaw shall take effect on the date of third reading.
