2025 Road Program Results

RECOMMENDATION

That Council directs administration to add the portion of Glen Park Road between Range Road 251 and the Queen Elizabeth II Highway to the 2025 Road Program for a value of \$1,400,690, with funding by debenture borrowing.

BACKGROUND

As per the 2025 Major Projects/Capital Plan (MPCP) the road projects were grouped into two separate tenders based on the location and scope of work for each project.

1. Tender No. 1 (IFT No. 25-004), Glen Park Road Mill and Overlay Project

This project consists of the resurfacing of two segments of Glen Park Road:

- Glen Park Road from Range Road 263 to Highway 795
- Glen Park Road from Highway 778 to Highway 39

The tender was advertised on December 11, 2024, and 14 bids were received and were opened on January 21, 2025. The official tender results are as follows:

County staff and the consultant (ROHI Engineering) completed the review of all tenders and found no issues with the bids. Based on the evaluation criteria, which includes tender price, past performance, references from similar past projects, and proposed methodology, Central City Asphalt Ltd. was the successful bidder. As a result, the contract was awarded to Central City Asphalt Ltd. The contractor has been advised to submit their work plan and an updated schedule.

Understanding that the results are significantly under the anticipated budget, administration recommends taking advantage of the favourable pricing and amend the 2025 road program to include the segment of Glen Park Road between Range Road 251 and the Queen Elizabeth II Highway. In discussions with the successful contractor, the estimated construction cost for this project will be \$1,225,690. The part of Glen Park Road between Highway 2A and Range Road 251 was resurfaced in 2021 in conjunction with replacing a failed culvert on Glen Park Road. The new project would complete the road segment between Highway 2A and the Queen Elizabeth II Highway. The overall cost of the project, including construction, engineering and contingency will be \$1,400,690.

- 14 Avenue, Nisku from 10 Street to 12 Street
